[origin: WO2022036026A1] The present invention generally relates to methods for curing and/or manufacturing silicone-coated release liners used e.g., in the production of pressure sensitive, peel-and-stick labels. In particular, the present invention is directed to silicone release coatings curable by LED, and methods for preparing silicone release coatings and curing such coatings with or without the need for nitrogen inerting or the addition of oxygen scavengers.
