[origin: EP4201234A1] Provided is an aerosol generating apparatus, including: a housing forming an accommodation space in which an aerosol generating article is accommodated; a heater unit heating the aerosol generating article accommodated in the accommodation space; a first cartridge including a first aerosol forming agent; a second cartridge including liquid nicotine and a second aerosol forming agent; a first cartridge heater unit heating the first cartridge; a second cartridge heater unit heating the second cartridge, and a control unit controlling the aerosol generating apparatus to operate in a set mode of a smoky mode and a smokeless mode.
