[origin: WO2022013327A1] Method and system for releasing the residual pressure of a hydraulic circuit of a work machine and work machine including the system Method for releasing the residual pressure of a hydraulic circuit of a work machine, the hydraulic circuit comprising a source (P) of pressurized hydraulic liquid and a discharge tank (T) of the pressurized hydraulic liquid and at least a double-action hydraulic actuator (A1, A2,...) controlled by means of a corresponding actuation hydraulic valve (V1, V2, V3,...), wherein the actuation hydraulic valve has a stand position in which it directs pressurized hydraulic liquid from the source to the discharge tank and, at the same time, compartments opposite chambers (C11, C12; C21, C22; of the corresponding actuator (A1, A2,...) and two opposite actuation positions in which the valve connects the first chamber (C11, C21) with the source and a corresponding second chamber (C12, C22) with the discharge tank, and vice versa, the method comprising a first preliminary step of checking or forcing a deactivation of the source (P) and a subsequent second step of activating alternately the two opposite actuation positions.
