Abstract (en)

[origin: WO2022129766A1] The invention relates to a method for manufacturing a food product in the form of pellets, sausages or pucks, comprising:
- a step of simultaneous kneading and cooking of a mixture formed from a flour and/or semolina of a cereal containing gluten, a tuber product of *Solanum tuberosum* and a liquid, in order to obtain a pasty composition (C); and - a step of forming pellets, sausages or pucks from the pasty composition, the simultaneous kneading and cooking step and the forming step being carried out successively in a manner distinct and independent of one another.
