Abstract (en)
[origin: EP4218444A1] The present application provides a heater assembly and an aerosol-forming device. The heater assembly includes a heating body. The heating body is configured to be inserted into and to heat an aerosol-forming substrate. The heating body includes a first segment portion and a second segment portion spaced apart from the first segment portion, the second segment portion is connected to an end of the first segment portion. At least a portion of the first segment portion and at least a portion of the second segment portion are configured to be inserted into the aerosol-forming substrate and to generate heat, when being supplied with power, to heat the aerosol-forming substrate. The heating body in the heater assembly can be directly inserted into the aerosol-forming substrate and is highly stable. Further, the heating body may heat the aerosol-forming substrate more uniformly.
