Abstract (en)  
[origin: WO2022073674A1] The invention relates to a method (100) for operating a machine (200, 300, 400, 500) in a processing plant for containers (20), in particular drinks containers, wherein the containers (20) are processed and/or transported (101) by the machine (200, 300, 400, 500), wherein at least one input signal and at least one output signal of the machine (200, 300, 400, 500) are acquired (102) during the processing and/or the transport, wherein a self-identification model of the machine (200, 300, 400, 500), which model reproduces at least one current operating point of the machine (200, 300, 400, 500), is determined (103) based on the at least one input signal and the at least one output signal, wherein at least one machine parameter of the machine (200, 300, 400, 500) and/or of a downstream machine is automatically configured or optimised (105) using the self-identification model, and/or wherein a diagnosis of the machine (200, 300, 400, 500) is automatically carried out (106) using the self-identification model.
