Abstract (en)

[origin: WO2022104764A1] This disclosure relates to method and device for serving a user equipment by a first wireless network node. In one implementation, the method may include transmitting a request message for a non-radio-communication service resource of a second wireless access network node to the second wireless access network node. The first wireless access network node may provide the user equipment with a non-radio-communication service and request the non-radio-communication service resource to assist to provide the non-radio-communication service to the user equipment. The method may further include receiving a response message allocating the non-radio-communication service resource for the user equipment from the second wireless access network node.
