Abstract (en)

[origin: WO2022101211A1] This method comprises the following steps: - recovering and compressing a top stream (98) from a separating column (34) in order to form a compressed purified natural gas stream (102); - liquefying the compressed purified natural gas stream (102) in a liquefaction unit (24) in order to form a stream (120) of pressurized liquefied natural gas; - flash expansion of the pressurized liquefied natural gas stream (120) and recovery in a storage tank (66); - recovery and compression of a flash gas stream (126) resulting from the expansion; - separating the compressed flash gas stream (132) into a fuel stream (20) and into a recycle stream (134); - cooling and expansion of the recycle stream (134), then introducing the cooled and expanded recycle stream at a top stage of the separating column (34).
