Abstract (en)

[origin: WO2022126162A1] The invention relates to an assembly (1) for guiding at least one movable furniture part (2), in particular a sliding door or folding sliding door, relative to a furniture carcass (3), said assembly comprising: at least one guide system (4) which is or can be fastened to the furniture carcass (3); at least one support (5) on which the at least one movable furniture part (2) is or can be mounted, in particular in a pivotable and/or articulated manner, and by means of which the at least one movable furniture part (2) can be moved relative to the at least one guide system (4); and at least one drive device (6) by means of which the at least one support (5) can be moved relative to the at least one guide system (4) and which has at least one cable (7), at least one coupling device (8) being positioned on the at least one movable furniture part (2) and/or the at least one support (5), and the at least one coupling device (8) being automatically couplable to the at least one cable (7) of the at least one drive device (6) during a movement of the at least one support (5) relative to the at least one guide system (4).
