Abstract (en)
The present invention relates to an active compound combination comprising a compound of formula (I) as defined in the application as well as a further fungicide, to a composition comprising such compound combination, and to the use thereof as biologically active agents, especially for control of harmful microorganisms in crop protection and in the protection of materials and as plant growth regulators.
