Abstract (en)

[origin: CN215075542U] The utility model discloses an electronic cigarette atomization device and an electronic cigarette, the electronic cigarette atomization device comprises a shell, an oil storage bin and an atomization assembly are arranged in the shell, and the shell is provided with an airflow channel communicated with the outside atmosphere; the atomization assembly comprises a porous body and a heating body, the porous body comprises a liquid absorption face and an atomization face which are oppositely arranged, the heating body is arranged on the atomization face, the porous body is provided with at least one ventilation channel, one end of the ventilation channel is communicated with the oil storage bin, and the other end of the ventilation channel is communicated with the outside atmosphere; the atomization assembly is sleeved with the first sealing piece, and the first sealing piece comprises at least one sealing part corresponding to the ventilation channel; the sealing part can open and close the ventilation channel to allow external atmosphere to enter the oil storage bin and prevent liquid in the oil storage bin from flowing out. According to the electronic cigarette atomization device, the problems that liquid in the shell is not smoothly discharged and oil leaks can be effectively solved.
