Abstract (en)

[origin: CN117302716A] The invention relates to a replaceable cosmetic container. According to one aspect of the present invention, it is possible to provide a replacement cosmetic container comprising: a replacement container capable of storing contents; and a container main body selectively coupled to the replacement container, in which a fixing groove is formed in the replacement container, and an elastic part is formed in the container main body, the elastic part being elastically deformable by an external force applied to the replacement container, and the elastic part being elastically deformable by the relative rotation of the replacement container and the container main body. And the fixing plate can be fixed on the fixing groove. The replacement cosmetic container according to one embodiment of the present invention has the advantages of firmly fixing the replacement container and the container main body during use, and easily separating the replacement container and the container main body during replacement of the replacement container.
