Abstract (en)
Construction element (1) production device comprising a hopper (2) for input of construction material (12) into an extruder (21) that pushes said construction material (12) towards a nozzle (3), wherein said nozzle (3) comprises at least a first rectangular section (33) and a second rectangular section (34) laterally offset from each other and at least partially joined along their largest faces (11a). The invention also relates to a production system associated with a construction element (1) production device having a screw extruder (21). A method of producing construction elements (1) using the aforementioned production system is also claimed, as is a construction element (1) obtained through this method. The construction element (1) comprises a plurality of rectangular prisms (11) joined along parts of their largest faces (11a). This allows an easy placement thanks to a self-assembling structure, while limiting sonic and/or thermal transmission.
