[origin: WO2022214498A1] The invention relates to a lighting device (1) comprising an illumination device (4) for illuminating an object, an arm (3) comprising the illumination device (4), wherein the illumination device (4) is arranged approximately parallel to the arm (3), and a position adjustment device (2) having a linear guide device, wherein the arm (3) and the illumination device (4) are translationally displaceable along a linear axis (7) by means of the position adjusting device and the arm (3) is arranged orthogonally to the linear axis (7).
