Abstract (en)

A gas turbine engine component (30) includes a substrate (32) having first surface (34) and a second surface (36) disposed opposite the first surface (34), a plurality of holes (40) extending through the substrate (32) from the first surface (34) to the second surface (36), the holes (40) defined by a plurality of respective walls (40a, 40b) each extending from the first surface (34) to the second surface (36), a metallic bond coat (38) disposed on the first surface (34), and an aluminide coating (42) disposed on the first surface (34), the second surface (36), and the walls (40a, 40b). The metallic bond coat (38) is disposed between the first surface (34) and the aluminide coating (42) and the walls (40a, 40b) are free of the metallic bond coat (38).
