[origin: CN117678840A] One aspect of the invention relates to a detachable chain (2) connectable to a main body (3) of a portable object (1), said chain (2) being provided with a flexible main body and comprising at least one fastening end (15a) for fastening said chain (2) to the main body (3) of said portable object (1), said fastening end (15a) comprising an attachment area (5) provided with two rigid fastening portions (4a, 4b), the invention relates to a chain (2) for a portable object (1), comprising two rigid fastening portions (4a, 4b) of an attachment area (5), and a deformable portion (6) configured to assist in reversibly fastening the chain (2) to the body (3) of the portable object (1) and arranged between the two rigid fastening portions (4a, 4b) of the attachment area (5).
