Abstract (en)
A method of washing ware in a dishwasher wherein the dishwasher comprises a washing chamber and a door to close the washing chamber, the method comprising the steps of: starting a dishwashing program; automatically locking the door and keeping it locked for the whole duration of the dishwashing program; and dosing at least 100 mg of active enzyme into the washing chamber.
