Abstract (en)  
A running jacket (4) comprising a backrest (8) and a front portion (12) provided with at least one front pocket (28) provided with a rear wall (32) and at least one front wall (36) opposite the rear wall (32), said rear walls (32) and front wall (36) delimiting a containment volume for an associable flexible bottle (40). The containment volume extends along a longitudinal direction (Y-Y), from a closed lower edge (44) to an open upper edge (48). The front wall (36) is closed on the rear wall (32) at a first side edge (52) that extends longitudinally between the closed lower edge (44) and the open upper edge (48); the front wall (36) is open and separated from the rear wall (32) at a second side edge (56), opposite the first side edge (52), with respect to a transverse direction (X-X). Advantageously, the front wall (36) is provided with closing and opening means (60) configured to respectively allow the locking/unlocking, with respect to the rear wall (32), of at least one flap portion (64) of the open upper edge (48) and/or of the second side edge (56) of the front wall (36).
