

(54) Improvements in casks and like containers.

(57) A cask or container for liquid under pressure having a housing 12 welded to the cask wall 10 around the bung hole 11, this housing serving as the sole support for a spring loaded ring seal 18 and an extractor tube 15 and its head 15a which is concentric within the seal 18.
