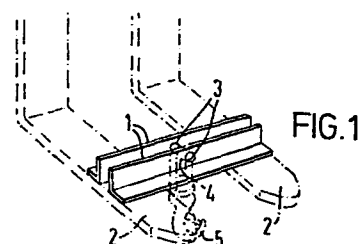

(54) **A load lifting attachment for use with a fork lift truck, hoist, crane or the like.**

(57) A load lifting attachment for use with a fork lift truck, hoist, crane or the like comprising a member (1) adapted at each end to be engaged with a fork (2) of a truck and fitted between said ends with a swivel hook (5) that can be engaged with a hoist or crane or have a load suspended therefrom, each end of said member (1) being provided with a shackle (8) to which lifting ropes, chains or the like can be engaged and the load evenly spread, balanced and controlled.
