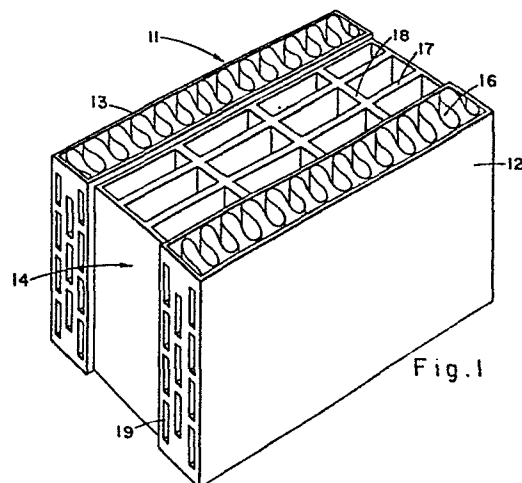

54 **Acoustic building blocks.**

57 An improved acoustic building block structure (11) for attenuating unwanted vibrations comprising:

A structure section having a front side, (12) a back side (13) oppositely disposed from said front side, (12) a composite unit having at least two vibration attenuating components, (16) and said component lying in the path of vibration from front side (12) to the back side (13).
