54 **Reinforced fabric laminate.**

57 A method of making a low cost, nonwoven reinforced fabric laminate comprising two layers of fibers lightly entangled by means of fluid jets, each layer having binder at the jet surface thereof, and a reinforcing layer therebetween, comprising superimposing the two fibrous layers and the reinforcing scrim with the non-binder side of the fibrous layers next to the scrim and securing the reinforcing layer to each of the fibrous layers.
