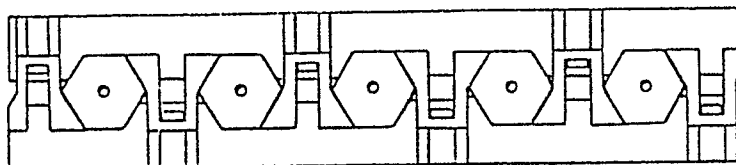

54 **Holder for drill steels and similar products.**

57 Holder for drill steels and similar objects, comprising several cavities (9) extending across the holder and having cross-sections essentially corresponding to half the cross-section of the drill steels so that several steels can be held together in the cavities between two holders facing each

other. The holder is provided with locking means (12, 13) arranged in such a manner that two holders facing each other can be held together by mutual engagement of the locking means (12,13).
