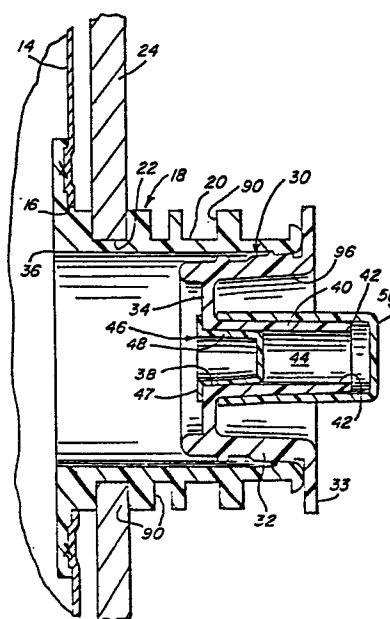

54 **Bag-in-a-box closure and flow-fitting therefor.**

57 A closure plug (30) for a bag-in-the-box fluid container, formed as a cylindrical flanged body (32) having a unitary transverse wall (34), an axial opening (38) in said transverse wall (34) and a hollow tapered tube (40) unitary with said wall surrounding the opening and extending within the body and parallel thereto. The tube tapers toward a narrow outlet exterior of the flanged end of the body. A dislodgeable inner plug (46) is seated in the tube entrance blocking same and a cap (50) is fitted over the outlet of the tube. Several connector fittings are disclosed which are coupled to the closure and carry a plunger dislodging the inner plug. The plug is maintained in sealing condition within the tube by the internal fluid pressure within the fluid container.
