

wherein, for example in a preferred embodiment R is t-butyloxycarbonyl, m and n are each 0 or 1, their sum being at least 1; R1 is cyclohexylmethyl; R2 is 2-methylpropyl, 2-methyl-2-propenyl, benzyl, 4-chlorobenzyl, 3-chlorobenzyl, 4-methylbenzyl, 4-methoxybenzyl, 3,4-dichlorobenzyl, 2-chlorobenzyl or cyclohexylmethyl; ${\sf R}^3$ is hydrogen; ${\sf R}^4$ is methyl, 4-aminobutyl, 2-carboxyethyl, hydrogen, 3-(ethoxycarbonyl)propyl or 3-(benzyloxycarbonyl)-propyl; W is phenylalanyl, W1 is histidyl and W2 is lysyl.

These compounds are useful for inhibiting the angiotensinogen cleaving action of the enzyme renin having particular utility in the treatment of hypertension.

	Claims 4-7,9 and 1-3,10 partially: Peptide derivatives of the formula on page 87, lines 2-8, and their protected C-terminal moieties (claim 10, page 90, lines 19-23), as far as not covered by the scope of subject 1. NOTE: This subject still contains a wide range of very different compounds, for which the search authority could not distinguish unifying inven- tive concepts. A search for this subject would have resulted in further non-unity objections.
