

⑰ Inking system for flexography printing plates.

⑱ Inking system for flexography printing plates, for the inking of curved printing plates (5) assembled on the carrying roller (3) placed between an inking roller assembly (11, 12, 13) and a backup roller (4), characterized in that it comprises an inking roller assembly (11, 12, 13) in which a first roller (11) has a reticulated surface serving the aim to pick up the ink from a container (9) in which said first roller (11) is partially submerged, said first roller (11) engaging in tangency the surface of the second roller (12), which is soft in its surface, having the possibility of adjusting the pressure in the tangency point of both rollers (11, 12) which are mounted on the same displaceable support (16) which carries as well the third roller (13) of the assembly, which surface is smooth.
