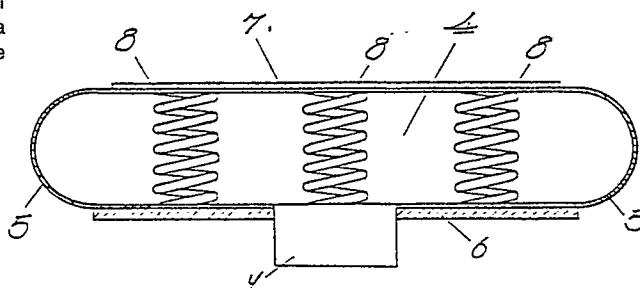

⑤⑦ An improvement of a vibrostimulative device wherein the vibration from a vibration generator (1) is transmitted to a vibratory member (7) through a closed gas space (4), the improvement comprising providing a closed gas space (4) of variable shape, and supporting the vibratory member (7) with a resilient support member (8) to maintain the closed gas space (4).
