(54) Knitting process.

The A double-faced knitted structure having on one or both faces a plurality of irregular puckers is produced by knitting on a knitting machine having a pair of opposed needle beds. At least two ends of noncontractible yarns are knitted on said needle beds to produce at least two knitted courses and at least one end of a contractible yarn is laid-in between the faces of said double-faced knitted structure and is intermittently attached to the knitted structure along the length of said two courses.


