

Piling.

This invention relates to the provision of piles (1) the lengthwise edges of which are formed to define a trough and in which the piles are so disposed that the troughs interlock, the inner faces thereof in adjoining piles being clamped tightly together by wedges (2) sited at intervals along the length of the

piles between the outer face of the trough on one said pile and the adjacent surface of the adjoining pile. The piles may be of commonly known Larssen section, the interlock or 'clutch' between them then lying on the centreline of the piling structure.
