

LACK OF UNITY OF INVENTION

The Search Division considers that the present European patent application does not comply with the requirement of unity of invention and relates to several inventions or groups of inventions, namely:

- 1. Claims 1-13: Liquid container with a path forming member.
- 2. claims 14-18 : Details about the mouth of a liquid container.

WO-A-86/00868 and EP-A-0 138 620 both describe a liquid container comprising an outer box, a flexible inner bag, a mouth fixed to the bag and a path forming member provided in the bag for maintaining a liquid path to the mouth as the bag deforms.

These documents destroy the novelty of claims 1 and 6. As a consequence, the other claims refer to two different problems and their technical solution, which do no longer present a common new and inventive idea, notably:

- 1. Claims 2-5,7-13: Liquid container with a path forming member allowing the contents to be taken out almost totally.
- 2. Claims 14-18: Liquid container wherein the mouth is constructed so that a liquid with a high viscosity flows out slowly.

Only claims 1 and 6 as well as the first subject has been searched.
