The invention relates to a drivable watercraft (1) comprising a drive boat accommodating portion (18) defining a docking area opening reward at a stern portion of the watercraft and adapted to accommodate power drive means, specifically a water jet propulsion unit such as a jet propulsioned boat (2) therein. Such a watercraft is improved in that a seat

area (12,13,14) is provided at least in front of the drive boat accommodating portion of the driven water craft and a bottom plate arrangement is provided within said docking area ensuring a smooth even flow of water through a water intake opening (20) of the power drive means received in said docking area.

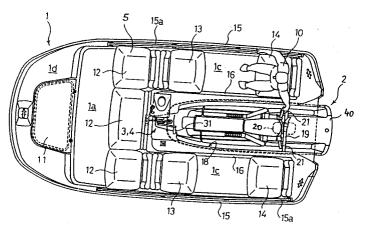

LACK OF UNITY OF INVENTION

The Search Division considers that the present European patent application does not comply with the requirement of unity of invention and relates to several inventions or groups of inventions, namely:

All claims relate to a drivable watercraft, adapted to be driven by a water jet propulsion unit, and provided with seating area in front of or beside the docking area for the drive unit, and a bottom plate arrangement in the docking area. Such a watercraft is known or obvious from GB-A-2 046 689, however.

Inventions searched:

1.	Claims	1,2,6-13	. :	The problem of propelling such a craft is solved by utilising a water jet propulsion boat as the power drive means and adapting the shape of the driven boat to provide hydrodynamic efficiency.
2.	Claims	3-5	:	The problem of accommodating crew and passengers on said boat is solved by particular seating arrangements.
3.	Claim	14	:	To snugly accommodate the drive boat in the docking area, bumper means are provided in the area.
4.	Claim	15	:	The problem of propelling the driven craft is alternatively solved by providing support means for an outboard motor.
5.	Claim	16	:	The problem of retaining the drive boat in place is solved by engaging it with a ladder on the stern of the driven boat.
6.	Claim	17	:	The versatility of the watercraft is improved by making the docking area closable at the stern to provide a play lot for the users.

Given that the common features of the groups of claims identified are known or obvious, no common inventive concept can be seen in the remaining features.
