

Electric lamp with improved cap fixation.

57) Electric lamp (1) with improved cap fixation, comprising a light emitting member and current conductors connected thereto and a glass envelope (2) having a substantially cylindrical neck-shaped end portion (5) over which an end portion of a metal lamp cap (8) comprising a cylindrical and a screwthreaded portion connected by a conical intermediate portion is arranged. Along two opposite generatrices of the neck-shaped portion (5), two elongated recesses (7, 7'), one in each opposite position and extending over the neck portion (5) formed to accept the metal lamp cap (8), are provided and the neckshaped portion (5) is also provided with an annular recess (6). A metal lamp cap (8) is slid over the neck-shaped portion (5), the cylindrical portion of the metal lamp cap (8) is provided with a pair of elongated rib type elements (9, 9') engaging in the elongated recesses (7, 7') of the neck-shaped portion (5) and, in the cylindrical portion of the metal lamp cap (8), engaging lugs (11, 11') are formed from the pair of strip-like portions (10, 10') determined by two pairs of adjacent slots (12) made in the cylindrical portion of the metal lamp cap (8), while the lugs (11, 11') fit the annular recess (6) in positions opposite to each other.
