- [54] Ink guide assembly and ink tank for a dot matrix printer head.
- The ink absorbing means comprises at least one porous member (60") which is compressed in vicinity of an ink supply guide (12) of an ink supply guide (12) is inserted into the ink tank (2") and has an ink supply port (41) which is arranged to receive ink and transmit ink via the ink guide assembly to printing means. 
