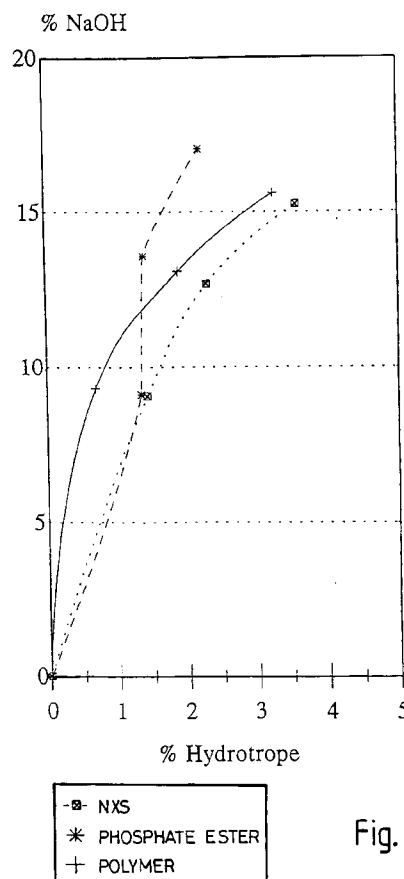

(54) Improvements in or relating to hydrotropes

(57) An aqueous composition, such as a household, industrial or institutional cleaning product, comprises electrolyte, surfactant and polymeric hydrotrope. The polymer preferably comprises (meth) acrylic acid and styrene, with a molecular weight in the range 1,000 to 1,000,000, and is substantially non cross-linked.
