⁵⁴ Film-forming silicone emulsion composition.

(57) A film-forming silicone emulsion composition which forms a film exhibiting a good adhesion to various substrates, and having a good water repellency and good release properties, comprising the following components which are mixed and dispersed:

- (A) a silicone emulsion comprising:
 - (a) a specific organopolysiloxane containing at least one amino group or epoxy group per molecule;
 - (b) an emulsifying agent; and
 - (c) water; and

(B) a specific hydrolyzable silane containing at least one functional group per molecule.
