(54) **Driving clutch operated by means of a roller blind tape from the lower collection casing.**

(57) It is based on a cylindrical case with cover (2) and a strip steel (4) rolled around a central socket (5) with its free end bored (12) and fixed to the socket by means of hooks (6). This socket houses, in turn, a clutch socket (1) attached to the cover and body of the case while the lower end of the strip steel is fixed by means of another bore (11) to a pin (3) protruding from the case.

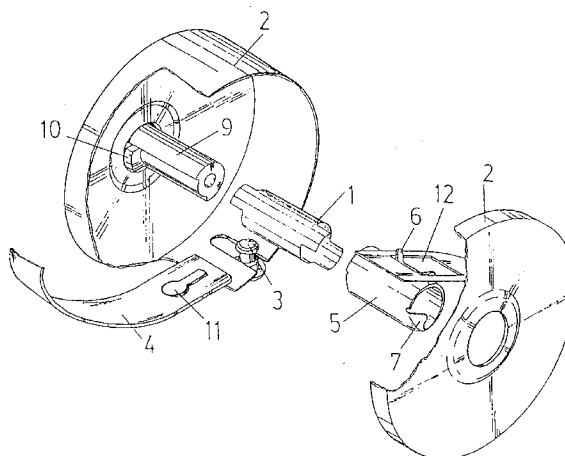
