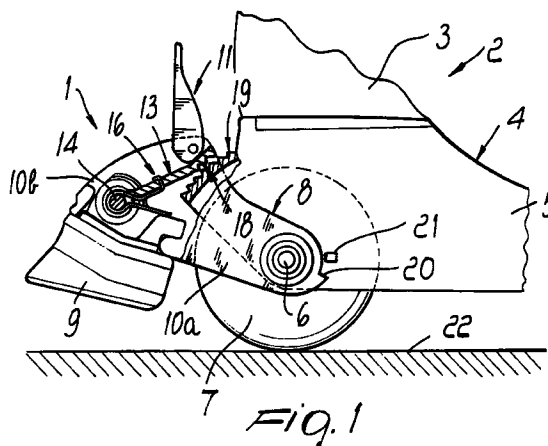

(54) **Braking device, particularly for roller skates**

(57) A braking device, particularly for skates which includes a shoe (3) associated with a frame (4) having a plurality of wheels (7) and a support (8) for a brake pad (9) in a rear region to the frame. The device comprises a ratchet member (18,19) for selectively positioning the support with respect to the frame.
