

(54) Swivelling snaphook

(57) A swivelling snaphook (10) is provided including a retainer (14) rotatably connected with a hook member (12). The retainer (14) includes a receptacle (30), two converging bars (32,34) joined to opposite sides of the receptacle (30), and a base bar (36) connecting the ends of the converging bars (32,34) distal to the receptacle

tacle (30). The receptacle (30) includes an internal wall (42) defining an orifice (44) extending through the receptacle (30). The internal wall (42) includes three resiliently deformable projection segments (176) extending into the orifice (44). The hook member (12) includes a hook body (18) and an insertion member (22) for insertion into the orifice (44) of the receptacle (30).
