

(54)Device for cyclically varying the water flow for hydromassage delivery nozzles

A device for cyclically varying the water flow for delivery nozzles of hydromassage baths is provided with a closing member (30) housed inside a cylindrical body (26) located between the delivery nozzle (10) and the water supply pipe (16). The closing member (30) is actuated by a propeller (38), arranged inside the sleeve (28), via a mechanism (40) comprising an endless screw (42) and a helical gear (44).
