(54) Shelf unit with sliding shelves

(57) This is a shelf unit which includes at least two uprights (11) connected together by crosspieces (12) ranged at different heights on the uprights, several ledges or shelves (13) attached to said crosspieces, and

where each ledge or shelf is sliding and moves horizontally along said crosspieces in the space between the uprights. Each ledge or shelf may hold at least one box or container, the contents of which may be removed from above.

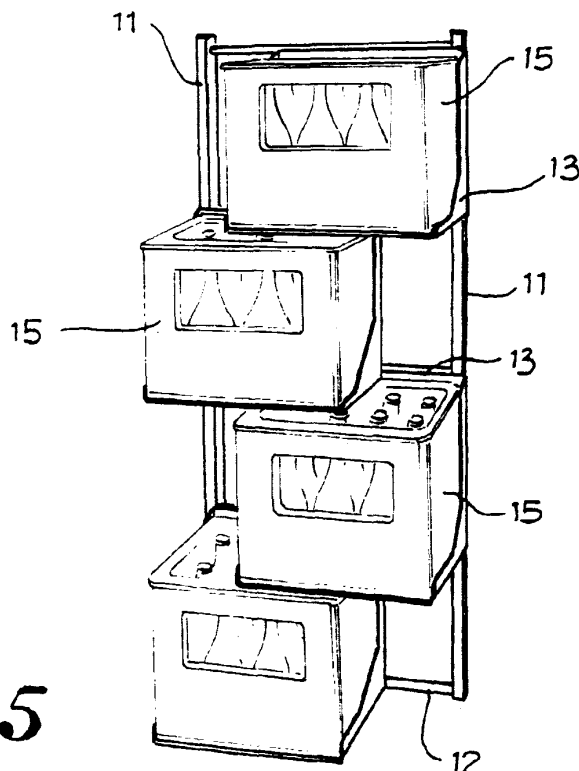
