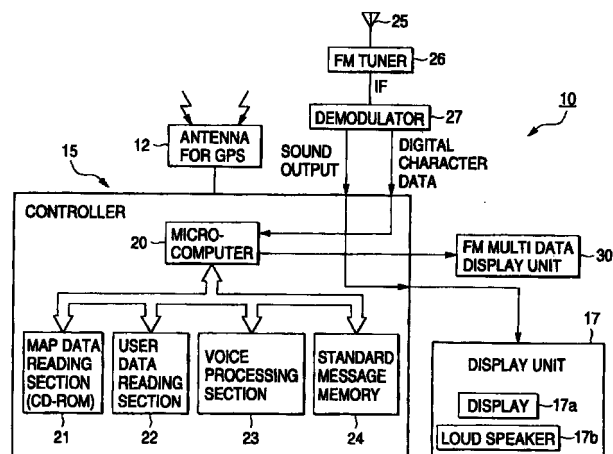

(54) **Car navigation system with FM multi-broadcast signal receiving function**

(57) A car navigation system with an FM multi-broadcast signal receiving function has: a function of displaying a current position on a display 17a according to position data which is received through a GPS antenna 12 from a satellite; and an FM multi-data display unit 17 which is arranged on a dash board 31 in front of the driver's seat of a vehicle.
