

(54) Single-use container

(57) A single use container, intended in particular to contain liquid, semi-liquid, powdered or similar products, comprises a first external hollow body (1), made of a first material, a second internal hollow body (2), made of a second material differing from the first one, inserted in said external body and removably joined thereto, in which means (8) are provided for disconnecting said external and internal bodies of the container as to allow their separation after use for recovery and recycling of the single raw materials.
