

(54) A profiled sheet-metal roofing element for buildings

(57) A profiled sheet-metal roofing element (1) for buildings comprises, on one of the end edges, a first, substantially inverted U-shaped rib (3) with an internal vertical flange (9). In the vicinity of the other end edge which is to be fixed to the support structure (15), the sheet-metal element (1) has a second rib (10) having a shank (11) and a head (12) forming an engagement

tooth under which the vertical flange (9) of the first rib (3) of an adjacent sheet-metal element (1a) engages. The first rib (3) has an upper, substantially arcuate portion (4, 5, 6) and a lower portion comprising two flat sides (7) which are inclined to the vertical so as to converge downwardly.
