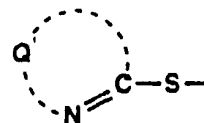
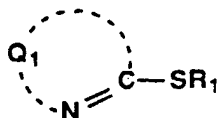

(54) **Stabilizing solution for processing silver halide color photographic light-sensitive material and method for processing silver halide color photographic light-sensitive material using the same**

(57) A stabilizing solution for processing a silver halide color photographic material and a method for processing a silver halide color photographic light material using the stabilizing solution are disclosed. The stabilizing solution contains a compound represented by the following Formula 1;

wherein Q₁ is a group of atoms necessary to form a nitrogen-containing heterocyclic ring, R₁ is a hydrogen atom, an alkali metal atom, a

group or an alkyl group, Q' is a synonym with Q₁.
