(57) A moon-phase dial mechanism comprising two overlapping, rotatable discs behind a substantially circular window representative of the moon.

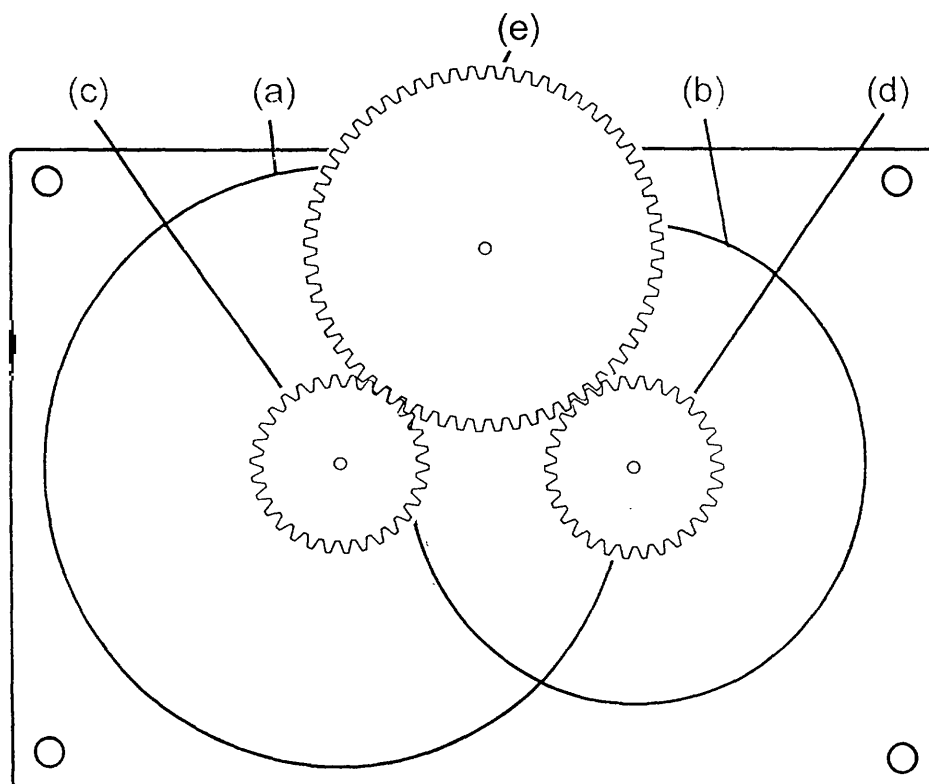
