(54) High-chair with means for adjusting the position of the seat tray

(57) A high-chair with means for adjusting the position of the seat tray, comprising a seat (3) which is associated with a supporting frame (2) and is provided with a tray (11) which is detachably associable with the seat.

The device further comprising means (20,21) for adjusting the distance of the tray (11) with respect to the back of the seat (3).


