(54) **A glass brick assembly**

(57) A method of forming a glass brick assembly (10) from a plurality of glass bricks (11), said method including the steps of providing upstanding end frame members (13) for defining the boundaries of said assembly (10), providing separation strips (21) for location

between adjacent courses of bricks (11), providing connectors at each end of said separation strips for connecting said separation strips (21) to said end frame members (13), and the end frame members (13) having locators locating each said connector with its adjacent end frame member.

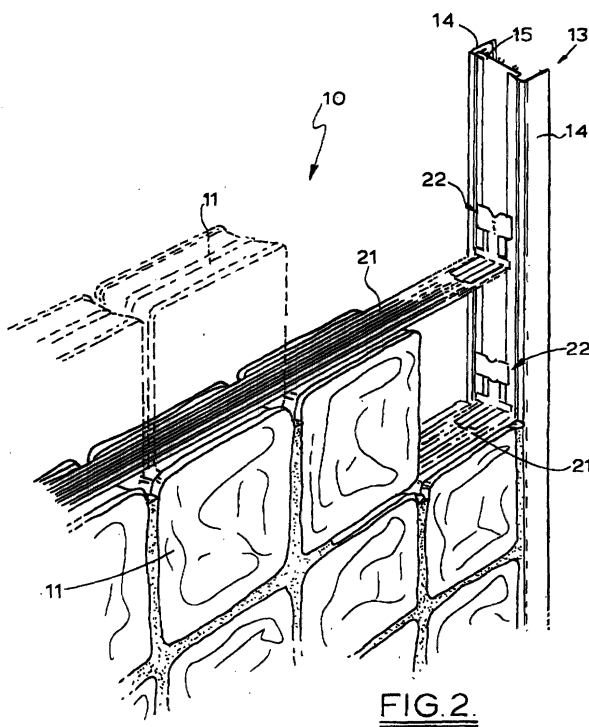
