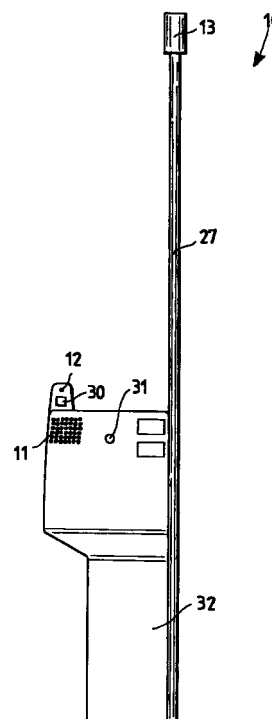

(54) **Emergency call unit, suitable for mounting in public areas**
