(54) **Engine device**

(57) An engine device having an engine body (6) provided with a crankshaft (7) and balancer shafts (8,9) adapted to rotate in association with the crankshaft (7), with the engine body (6) covered with an engine cover (58), whereby engine auxiliary (70,80) is integrally incorporated in the engine cover (58).

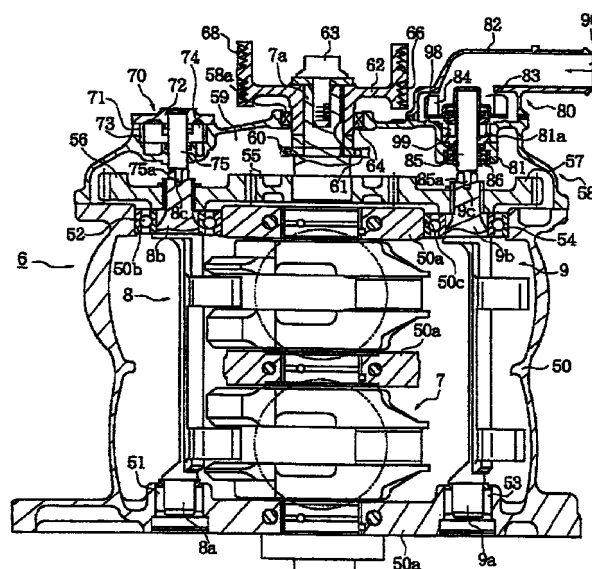
