(54) **Magnetic composition toy**

(57) Composition toy comprising a main template (1) representing certain figures and a number of secondary templates (5,6) which represent complements which may be applied to main template (1), with the union between templates (1,5,6) performed by magnetically attracting particles (4,8) concealed in the main template (1) and in secondary templates (5,6).

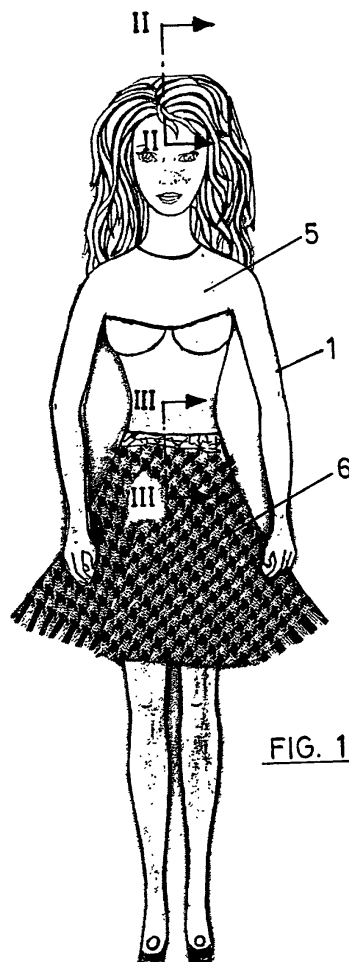
